



## Daniel E. Hunter

June 17, 1927 - February 25, 2007

Hunter, Mr. Daniel Eugene Hunter, 79 of Alpharetta died February 25, 2007 after a prolonged and courageous battle with cancer, which he faced with dignity and grace. Mr. Hunter was born and educated in Brooklyn, New York. He graduated from the United States Merchant Marine Academy. Mr. Hunter sailed with the Merchant Marine before becoming a Federal Bureau of Investigation (FBI) Special Agent. He joined Citizens and Southern Bank, Atlanta as Senior Vice President of Corporate Security. Mr. Hunter was commended by then FBI director William Webster for many heroic acts, including personally arresting armed bank robbers and putting his life on the line in order to rescue bank employees who were taken hostage. He served on many security related and bank commissions until his retirement. Mr. Hunter was loyal, hard working, and dedicated member of the Atlanta Chapter of the Society of Former Special Agents of the Federal Bureau of Investigation Association. He was member of Saint Thomas Aquinas Catholic Church, Alpharetta, GA. Dan was preceded in death by his son John Hunter. He is survived by his beloved wife of 55 years, Joan Hunter; his children, Daniel Hunter of Alpharetta, Kathryn Hunter Cunningham and her husband David of Roswell, Mary Hunter Bivins of Alpharetta, Joan Marie Hunter of Atlanta; his grandchildren, Christopher, Hunter, and David Cunningham, Elizabeth and Hunter Bivins, and Danny and Christina Hunter; brother and sister-in-law, John and Pat Hunter of Woodbridge, VA and many nieces and nephews.
