Kathryn “Kitty” Law Owens of Alpharetta, GA was called home to rest with the Lord February 23, 2023 following sudden unexpected cardiac arrest. Born in Danville, VA she was the daughter of the late Henry Tazewell Law and Charlotte Meadows Law. Kitty grew up in idyllic Chatham, VA.

Kitty is survived by her husband of 43 years, Richard Owens, son Baker Owens (Cara) and beloved grandson Emmett of Atlanta, as well as other partners, her horse Porter, and her two Norwich Terriers, Portia and Celia. She was touched early in life with a heart of passion for animals, particularly horses.
